WHO ARE WE?

We are the controller and processor of your data. We will use your information as defined in this Privacy Policy.

WHAT DATA DO WE COLLECT?

We do not collect data from third parties.

We only use data given to us by you via phone, email, fax or via our website.

We only collect data needed to provide our customers with the products and services that they require.

This will include:

- Company names
- Employee names
- Business addresses
- Email addresses
- Phone numbers
- Fax numbers

All of which will be provided by the customer/business.

We will collect additional information from customers who apply for and/or obtain credit accounts including:

- Bank account details
- Other financial information such as credit history

If at any time these details change, please contact us to update your information.

Whenever your account is used we will collect transactional information regarding goods purchased, payment method, date and time of purchase.

HOW AND WHY WE USE PERSONAL DATA:

We process your data so that we can provide you with goods and services.

These processes include:

- Managing & maintaining your account
- Any process required to provide you with goods and services, for example ordering, invoicing, crediting, payments and quoting
- Delivery of goods to your premises or to an address provided to us by you
- Considering an application for credit
- Communicating with you about your account, including notification of any changes, price increases and payments

HOW YOUR DATA IS STORED:

WHEN CAN WE USE YOUR INFORMATION?

We collect and use your information in the following circumstances:

 significant benefits of being able to provide and improve our products and services.
- With your consent: When filling in data on our website to request documentation we will ask for your consent to use this data for marketing purposes and on the rare occasion that we pass your data on to a third party, e.g. a distributor.

WHAT ABOUT MARKETING?

We would like to contact you from time to time about products and offers that we feel are of interest to you. We feel it is in both our and your legitimate interests as we feel it benefits both partied without compromising your data protection rights.

HOW LONG DO WE KEEP YOUR INFORMATION?

It is a legal requirement that we keep accounting records for a period of 7 years.

We will only keep your information for as long as it is necessary for us to fulfil the purposes that we describe in this policy and fulfil our legal obligations.

All data will be assessed regularly and deleted accordingly.

You have the right to rectify any data that is inaccurate or incomplete. Please contact us using the methods below.

You have the right to request deletion of data that we hold where there is no compelling reason for its continued processing and where the data is no longer necessary for the purpose for which it was originally collected.

WHO WILL WE SHARE YOUR DATA WITH?

We do not share your personal data with third parties except in the following circumstances:

- Where we have to pass on your details to a distributor we will only do this with your consent.
- Where it is necessary to do so in order to process your order for example with carriers/freight forwarders.
- With any law enforcement agency, court, regulator, government authority or other third party where we believe
 this is necessary to comply with a legal or regulatory obligation or, otherwise, to protect our rights or the rights of
 any third party.
- With any third party that purchase, or to which we transfer, all or substantially all of our assets and business. Should such a sale occur, we would use reasonable efforts to try and ensure that the entity to which we transfer your information uses it in manner that is consistent with this policy.
